- To be eligible to fish tournaments one person of the team must be a dues paying or retired member of the participating locals.
- All boat owners must carry a minimum of \$100,000.00 liability insurance.
- The use of drugs or alcohol is prohibited.
- In the event a person fishes alone a full entry will be required.
- A (1) pound penalty will be assessed for bringing a short fish to the scales.
- Any Team that brings fish to the scales without enough water to completely cover the fish will be disqualified.
- 5 fish limit per boat that can include 1 slot fish per person except lakes that have different length regulations.
- ANY BOAT NUMBERS NOT IN THE CONTAINER AT THE END OF OFFICIAL QUITTING TIME WILL NOT WEIGH FISH
- LIFE JACKETS AND KILLSWITCH MUST BE WORN AT ALL TIMES ABOVE IDLE.
- You and your Classic partner must have fished (4) tournaments together throughout the year to fish the classic together.
- To be eligible to fish the October 29th and 30th classic, one person of each team must be a member or retired member of a participating union and must have fished (6) of the (7) normal season tournaments.
- In the event that a team must "BUY" a tournament to qualify for the classic, it must be paid for before that event takes place
