1. All state, local and coast guard regulations apply
2. To be eligible to fish tournaments one person of the team must be a dues paying or retired member of the participating locals
3. All boat owners must carry a minimum of \$100,000.00 liability insurance
4. The use of drugs or alcohol is prohibited
5. In the event a person fishes alone a full entry will be required
6. You and your classic partner must have fished at least (4) tournaments together throughout the year to fish the classic together
7. In the event that a team must "buy" a tournament to qualify for the classic, it must be paid for before that event takes place
8. To be eligible to fish the November 2nd & 3rd Classic, one person of each team must be a member or retired member of a participating union and must have fished (5) of the (7) tournaments
9. A (1) pound penalty will be assessed for bringing a short fish to the scales
10. . Any Team that brings fish to the scales without enough water to completely cover the fish will be disqualified
11. 5 fish limit per boat that can include 1 slot fish per person except lakes that have different length regulations
12. **SIGN UP WILL CLOSE 30 MINUTES BEFORE SCHEDULED START TIME**
13. **ANY BOAT NUMBERS NOT IN THE CONTAINER AT THE END OF OFFICIAL QUITTING TIME WILL NOT WEIGH FISH**
